Public Offer

on the provision of a voluntary charitable endowment (gratuitous conveyance of property, funds) for generally useful (charitable) purposes

This Offer shall be addressed to an indefinite range of individuals and legal entities planning to endow (hereinafter referred to as the "Donor"), to visitors of the website of the Public Organization "Ukrainian Pet Association Worldwide" at: https://upaw.org/ (hereinafter referred to as the Website), and shall be an official and public offer of the Public Organization "Ukrainian Pet Association Worldwide", EDRPOU code 44791629 (hereinafter referred to as the Organization), represented by the Chairperson Oksana Volodymyrivna Koshak, acting on on the basis of the Charter, to conclude an Charitable Donation Agreement (hereinafter referred to as the Agreement), the subject and essential terms of which are as follows:

1. Terms and Definitions:

Public Offer shall be the current offer of the Organization, posted on the Website on provision of a charitable endowment, shall be addressed to an unlimited number of persons, including the Donor.

Acceptance shall be full and unconditional acceptance of the Public Offer by performing actions to make a money transfer through payment forms and means posted on the Website, as well as by transferring funds to the Organization's settlement account via banking institutions. The moment of Acceptance shall be the date of money transfer and/or crediting of funds to the bank settlement account of the Organization.

Charitable Endowment shall mean the implementation of a voluntary money transfer by the Donor to achieve and implement the goals, objectives, directions and types of statutory activities of the Organization in accordance with the Agreement, the Organization's Charter, and the Law of Ukraine "On Charitable Activities and Charitable Organizations".

2. Subject Matter of the Agreement

The subject matter hereto shall be the gratuitous conveyance of funds by making voluntary endowments to the ownership of the Organization for the implementation of the statutory activities of the latter.

Charitable Endowment shall be voluntary and not subject to further return to the Donor.

The Donor shall independently determine the amount of the Charitable Endowment.

If desired, the Donor may indicate the purpose of the Charitable Endowment by choosing among the programs (projects), the goals announced by the Organization.

- 3. Ways to Make the Charitable Endowment:
- Payment shall be in any amount.
- 4. Acceptance of the Offer shall mean that the Donor agrees with all its provisions and is fully aware of and agrees with the subject matter hereto, for the purpose of public collection of donations and with the right of the Organization to use a part of the Donor's Charitable Endowment for the administrative expenses of the Organization, in an amount not exceeding what is stipulated by the legislation of Ukraine.
- 5. The Donor and the Organization, guided by clause 2 of Article 207, clause 2 of Article 639, Articles 641, 642 of the Civil Code of Ukraine, shall agree that from the moment of Acceptance, the Agreement shall be considered concluded in writing. in addition, the Parties agree that their failure to comply with the written form of the deed shall not mean its invalidity.
 - 6. Rights and Obligations of the the Organization:
 - 6.1. The Organization shall have the right to:
 - receive Charitable Endowments and use them to achieve the goals, objectives, directions and types of statutory activities of the Organization in accordance with the Agreement, the Organization's Charter, and the Law of Ukraine "On Charitable Activities and Charitable Organizations".
 - change the direction of using the Endowment within the scope of Charter activities of the Organization without consent of the Donor;
 - use part of the Charitable Endowment for administrative expenses of the Organization without agreement of the Donor, in an amount not exceeding what is stipulated by the legislation of Ukraine. 6.2. The Organization shall:
 - use the received Charitable Endowments in accordance with the subject and conditions hereto, the Organization's Charter, and the Law of Ukraine "On Charitable Activities and Charitable Organizations".
 - report on use of the Charitable Endowment in the manner prescribed hereto and by the current legislation of Ukraine.
 - 7. The Donor shall have the right to control the intended use of the Charitable Endowment.

8. Location of the Public Fundraiser:

Public fundraiser of the Charitable Endowments shall be carried out on the territory of any country in the world. Direct activity of the Organization related to the public fundraiser of the Charitable Endowments under the Agreement shall be carried out at the location of the Organization.

9. Fundraising End Date:

Public fundraiser of the Charitable Endowments shall continue until the moment of liquidation of the Organization, unless otherwise determined by the Organization.

- 10. Purpose of Fundraising and the Procedure for Using Charitable Endowments:
- The Organization shall raise funds
- to help victims of the military aggression, animal owners, shelters and guardians of homeless animals, with the aim of free distribution among those in need who live/are in the war zone/on the territory affected by hostilities/temporarily occupied etc.
- for the development of ecology, environmental protection and animal protection, educational activities on the treatment of animals, public health, the development of territorial communities and the development of international cooperation.
- to support the Ukrainian people by financing various types of humanitarian aid for the population and assistance to the military in order to preserve life and ensure the protection of the territory of Ukraine, as well as further reconstruction of the state's infrastructure.

Charitable Endowments collected under the Agreement shall be used through the purchase and delivery of various types of humanitarian aid directly to animal owners, shelters and guardians of homeless animals who suffered as a result of the military aggression.

11. The order of General Access to the Financial Statement of the Organization:

Access to statement the use of Charitable Endowments of the Organization shall be granted upon written request of the Donor. Other information shall be provided by the Organization in the manner and terms provided for by the current legislation of Ukraine. The Organization may publish statement on the use of Charitable Endowments on the Website.

- 12. All expenses for the payment of amounts (fees) associated with the transfer and crediting of the Charitable Endowments shall be borne by the Donor.
- 13. The Donor shall bear responsibility for the accuracy of information provided when transferring the voluntary Charitable Endowment.
- 14. In order to comply with the Law of Ukraine "On the Protection of Personal Data" and fulfill the terms hereto, the Donor shall agree to the processing of personal data. The Organization shall not transfer the e-mail address and other data about Donors to third parties, except in the cases stipulated by the current legislation of Ukraine.
 - 15. Acceptance shall also mean that the Donor as a natural person is informed and agrees as follows:
 - The Donor provides the Organization with unconditional consent to the processing of his/her/their Personal Data provided when visiting the Website and/or making a money transfer (hereinafter referred to as the Personal Data), and is notified of the inclusion of such information in the personal database of the Organization and of all protection rights his/her/their Personal Data, provided for by the current legislation of Ukraine, namely Article 8 of the Law of Ukraine "On the Protection of Personal Data";
 - The Organization processes Personal Data in any way for the purpose of proper implementation hereto and its activities under the Charter.
- 16. The provisions of the legislation of Ukraine shall apply to relations between the Donor and the Organization.
