

Public Offer
about Receiving Humanitarian Aid

This Offer shall be addressed to an indefinite range of individuals and legal entities planning to apply for receiving Aid (hereinafter referred to as the "Applicant in Need"), to visitors of the website of the Public Organization "Ukrainian Pet Association Worldwide" at: [https:// upaw. org/](https://upaw.org/) (hereinafter referred to as the Website), and shall be an official and public offer of the Public Organization "Ukrainian Pet Association Worldwide", EDRPOU code 44791629 (hereinafter referred to as the Organization), represented by the Chairperson Oksana Volodymyrivna Koshak, acting on on the basis of the Charter, to conclude an Agreement on Receiving Humanitarian Aid (hereinafter referred to as the Agreement), the subject and essential terms of which are as follows:

1. Terms and Definitions:

Public Offer shall be the current offer of the Organization, posted on the Website on receiving of the Humanitarian Aid, shall be addressed to an unlimited number of persons, including the Applicant in Need.

Acceptance shall be full and unconditional acceptance of the Public Offer by taking actions related to the application for Humanitarian Aid, by filling out the form posted on the Website. The Acceptance shall occur as of the date of filling out the form on the Website.

Humanitarian Aid shall be voluntary, selfless and conscious activity of individuals or legal entities (Donors), expressed through personal and/or property support to individuals and legal entities, based on the principles of legality, humanity, equality and carried out with humane motives to achieve socially significant goals to achieve and implement the goals, objectives, directions and types of statutory activities of the Organization in accordance with the Agreement, the Organization's Charter, and the Law of Ukraine "On Charitable Activities and Charitable Organizations".

2. Subject Matter of the Agreement

The subject matter hereto shall be the free transfer of Humanitarian Aid by the Organization to the ownership of the Applicant in Need upon request of the latter, within the scope of the implementation of the Organization's statutory activities.

The Organization shall independently determine the amount of Humanitarian Aid to the Applicant in Need.

3. Ways of Receiving Humanitarian Aid:

- The Applicant in Need shall form a request for Humanitarian Aid by filling out a form on the Website
- The Organization shall process the request.

4. Acceptance of the Offer shall mean that the Applicant in Need agrees with all its provisions and is fully aware of and agrees with the subject matter hereto, for the purpose of receiving Humanitarian Aid and with the right of the Organization to refuse to provide Humanitarian Aid to the Applicant in Need.

5. The Applicant in Need and the Organization, guided by clause 2 of Article 207, clause 2 of Article 639, Articles 641, 642 of the Civil Code of Ukraine, shall agree that from the moment of Acceptance, the Agreement shall be considered concluded in writing. in addition, the Parties agree that their failure to comply with the written form of the deed shall not mean its invalidity.

6. Rights and Obligations of the the Organization:

6.1. The Organization shall have the right to:

- Alter content of the request of the Applicant in Need at its own discretion;
- Determine the date and time of the transfer of Humanitarian Aid to the Applicant in Need
- Refuse to satisfy the request of the Applicant in Need due to the lack of Humanitarian Aid available in the Organization;
- Refuse to satisfy the request of the Applicant in Need as related to the violation of provisions of the Law of Ukraine "On Humanitarian Aid" by the latter.

6.2. The Applicant in Need shall:

- use the received Humanitarian Aid exclusively for personal needs;
- report about receiving Humanitarian Aid.

7. The Organization shall have the right to control the intended use of Humanitarian Aid.

8. The Applicant in Need is aware that he/she/they may be held criminally or administratively liable for violating the legislation on humanitarian aid in the case of using Humanitarian Aid not for its intended purpose, as well as for using Humanitarian Aid for profit.

9. The End Date for Providing Humanitarian Aid:

The provision of Humanitarian Aid shall continue until the end of the martial law in Ukraine or liquidation of the Organization, unless otherwise determined by the Organization.

10. The Purpose of Providing Humanitarian Aid:

The Organization shall carry out free transfer of Humanitarian Aid

- to help victims of the military aggression, animal owners, shelters and guardians of homeless animals, who live/are in the war zone/on the territory affected by hostilities/temporarily occupied etc.

11. In order to comply with the Law of Ukraine "On the Protection of Personal Data" and fulfill the terms hereto, the Applicant in Need shall agree to the processing of personal data. The Organization shall not transfer the e-mail address and other data about the Applicant in Need to third parties, except in the cases stipulated by the current legislation of Ukraine.

15. Acceptance shall also mean that the Applicant in Need as a natural person is informed and agrees as follows:

- The Applicant in Need provides the Organization with unconditional consent to the processing of his/her/their Personal Data provided when visiting the Website and/or forming a request for Humanitarian Aid (hereinafter referred to as the Personal Data), and is notified of the inclusion of such information in the personal database of the Organization and of all protection rights his/her/their Personal Data, provided for by the current legislation of Ukraine, namely Article 8 of the Law of Ukraine "On the Protection of Personal Data";
- The Applicant in Need shall provide the Organization with unconditional consent to the use and publication of photos and videos of the Applicant in Need in social networks and articles when covering issues of Humanitarian Aid and reporting to Donors.
- The Organization processes Personal Data in any way for the purpose of proper implementation hereto and its activities under the Charter.

16. The provisions of the legislation of Ukraine shall apply to relations between the Applicant in Need and the Organization.
